(Hereinafter referred to as "the Program"). I shall not make any objection to the repatriation under below terms and conditions.

I. GENERAL CONDITIONS:

- 1. The Student understands the financial implications of participating in the program, and apply to the program with the approval of one's parent/guardian who will be financially supporting me.
- 2. The Students understands that it is not allowed to decline candidacy once accepted as the program participant. Withdrawal from the program will only be permitted under exceptional and unavoidable circumstances which UTokyo duly regards to be valid.
- 3. The Student shall take full responsibility of one's preparations and arrangements required to participate in the Program (such as preparation and submission of paper work required by the host institution, completing the procedures required by UTokyo, making necessary travel arrangements, including obtaining passport and visas, payment of costs and fees associated with the participation of the Program, purchasing appropriate insurance coverage for the duration of the Program etc.) .
- 4. The Student should have an insurance during study abroad at one's own expense, which will cover the exchange period from leaving Japan to returning Japan.
- 5. The Sutdent should confirm one's presence at host institution to UTokyo every month during the Program.
- 6. The Student should commit oneself to one's study or research activities in order to achieve the objective of the Program, and transfer the credits earned from host institution .
- 7. The Student shall abide the laws, rules and regulations, and codes of conduct set forth by the authority of the host nation and Japan as well as the host institution. The Student understands the use of any kind of drugs prohibited by Japan is prohibited.
- 8. The Student should avoid any type of activities that may put one in danger.
- 9. On completion of the Program, the Student should return to Japan and shall resume one's study at UTokyo.

II. REPATRIATION ORDER AND SUSPENSION OF SCHOLARSHIP

1.UTokyo may suspend/postpone the participation of the Student in the Program in the event of the following reasons given below. If the Student is physically present in the host country, UTokyo may issue a repatriation order to the Student.

- (1) The Student violates the terms of Conditions described in section I above.
- (2) It has been found that the Student has made false declaration on one's application forms.
- (3) The Student is not complying with the proper code of conduct during the Program and is being a disturbing presence to other students.
- (4) The Student is subject to disciplinary action from the host institution.
- (5) The host institution has deemed that the Student would not be able to make the required academic achievements.
- (6) Security and safety in the host institution's country deteriorate.
- 2. The Student shall bear the full cost of the return travel associated with the repatriation order issued based upon the aforementioned points or on the Student's own decision to return early.

III. LIABLITY NOT ATTRIBUTED TO THE RESPONSIBILITY OF UTokyo

The Student acknowledges and accepts that UTokyo is not liable for any personal or material damages and that the Student shall not be entitled to any benefit, payment, subsidy, compensation, or entitlement resulting from any such incidents as follows:

- (1) Losses and damages caused by and/or associated with Natural Disaster, Marine Accident, Fire, Ordinance issued by Government or Public Institution, War, Conflict, Riot, Strike Action, Theft, Isolation, Terrorism, Hijacking, Aircraft Accident, Traffic Accident, Crime, Pandemic and/or Epidemic Disease, Custom Restrictions, change of the flight schedule, Force Majeure, and any other losses and/or damages caused by unanticipated and uncontrollable forces.
- (2) Losses and damages resulting from the Program Participant's act of violation of law and/or public order.
- (3) Any losses and damages caused by the Program Participant's negligence or intentional acts.
- (4) Any losses and damages caused by acts not consistent with the scope of purpose and mission of the Program.
- (5) Any losses and damages derived from the Participant personal problem.
